This Notice of Proposed New Special Event Permit Fees and Facility Use Charges is hereby provided by the City of Tolleson pursuant to ARIZ. REV. STAT. § 9-499.15. The new fees and charges, if approved by Mayor and Council, will be imposed by the City of Tolleson to cover the cost of the City providing services for special events held in the City and for facility rentals.

Pursuant to ARIZ. REV. STAT. ANN. § 9-511.01, a public hearing on the proposed adoption of the New Special Event Permit Fees and Facility Use Charges will be held before Mayor and Council on December 12, 2017 at 6:00 p.m. at the City of Tolleson City Hall Complex, 9555 West Van Buren Street, Tolleson, Arizona.
