SOQ Submittal: Statements of Qualifications (SOQ's) from qualified Design-Builder (DB) firms must be received electronically via the City of Tolleson's drop box folder. All interested parties must contact bidquestions@tolleson.az.gov to register for this RFP. All registered parties will receive a link to the City's drop box folder for submittals. **All submittals must be fully uploaded no later than 10:00 a.m. (local time, Phoenix, AZ), March 2, 2023.** The SOQ must include all information items listed in the RFQ in the order listed. Any SOQ received after the time specified will NOT be accepted. It is the Design-Builder's responsibility to ensure its SOQ is received as stated above on or before the specified time.

Project Description: This will be a Design-Build Project pursuant to A.R.S. § 34-603(A)(3). The City may award a contract to one person or firm (or a Design-Builder team) who will be responsible for design and construction services. A general description of the "Project" is to design and construct a pedestrian bridge south of Van Buren Street, crossing 91st Avenue. The structure will be both the figurative and literal bridge in connecting the community across the busy street to several schools and City services.

Pre-Submittal Conference: A pre-submittal conference will be held on **January 26, 2023 at 10:00 a.m., (local time, Phoenix, AZ) MST** at the City of Tolleson, 9055 West Van Buren Street, Tolleson, Arizona 85353, Pecan Room 159. It is highly recommended that all prospective firms attend as responsibility issues will be discussed along with Project requirements.

SOQ Format: Each SOQ received must be in accordance with the format and information provided within the Request for Qualifications package. Any submittal that does not conform, in all material respects to what is outlined in the RFQ, will be considered non-responsive. Each SOQ shall be submitted per the directions provided in the RFQ.

Right to Reject SOQ: Tolleson reserves the right to waive any irregularities in any submittal and to reject all submittals and re-advertise or cancel the Project in its entirety, at its sole discretion. Tolleson, or its consultants and advisors, will not be responsible for any cost incurred by any firm submitting an SOQ or responding to this notice.
