Listed below are **VIOLATION CODES** (not complaint numbers) with fine amounts which apply if paid by mail or in person without a court appearance. Mandatory State surcharges are already included. (*) means code is eligible for the Defensive Driving Program (see Page 1).

YOU MUST APPEAR IN COURT ON THE DATE AND TIME LISTED ON YOUR COMPLAINT IF:

- Any violation code on your complaint does not appear on this FINE/SANCTION SCHEDULE, or
- Your Complaint was issued as a result of an accident involving death or serious physical injury.

IF PAYMENT IS NOT RECEIVED BY YOUR COURT DATE, YOU MUST:

Add one \$20 Time Payment Fee to the amount to be paid.

A.R.S. 28-2532A - NO PROOF OF REGISTRATION - Mail or fax proof of current AZ registration and court will discuss ticket, otherwise fine is \$602.00

Payment must be received by your court date.

A.R.S. 28-3169A - NO DRIVER LICENSE IN POSSESSION
Will be Dismissed with proof of driver license valid ON DATE AND TIME COMPLAINT WAS ISSUED. Otherwise see above for fine amount.

A.R.S. 28-3473 - DRIVING ON A SUSPENDED LICENSE
If you are charged with a violation of 28-3473A or 3473B, you should contact the Motor Vehicle Department to find out how to have your license reinstated. By following M.V.D.'s procedures, your sentence on a 28-3473A may be reduced. If you are charged with 28-3473C, you should:

- Contact an M.V.D. office to determine what Court has your unpaid complaint(s).
- Pay complaint(s) in full at the Court where they are located.
- Pay reinstatement fee to M.V.D.
- Bring proof of reinstatement to this Court on your court date.

The reinstatement of your license can significantly affect your sentence.

28-924 to 28-931 and 28-957 to 28-959.01 - EQUIPMENT REPAIR
Fines may be waived if proof of repair(s) is shown to the court.

A.R.S. 28-907A - CHILD PASSENGER RESTRAINT
Mail receipt proving purchase of child passenger restraint system after date and time complaint was issued and fine may be reduced to \$0

A.R.S. 36-2853B Civil (Non-Criminal) \$760
Marijuana possession/use under 21
(all other 36-2853 offenses not listed must appear in court)

TRAFFIC SURVIVAL SCHOOL NOTICE: If you have been cited for 28-645A3A or are under 18 (First Offense) and are found responsible for a moving violation by the court, you will be required to attend a traffic survival school (TSS) class by the Motor Vehicle Division (MVD) pursuant to the requirements of the Arizona Revised Statutes. If you are eligible for Defensive Driving Class and complete the class, the violation will be dismissed, and you will not be required to attend TSS by M.V.D.
