



# Tolleson's Luces de Navidad 2020

## *FOOD TRUCK/FOOD VENDOR APPLICATION*

### **Process of Application:**

Food truck/food vendors who wish to participate at the Tolleson's Luces de Navidad event must submit an application and be approved by the City of Tolleson. We limit the number of booth spaces to ensure a high quality show of vendors. Due to limited space and the process of selection, some otherwise qualified applicants may not be selected.

Vendor application must be complete. (Attached to this form)

- ❖ Application will not obtain final approval without proper permits and city and state licenses.
  - This applies to all retail sales and services rendered for profit

### **Selection Process:**

1. The City of Tolleson will select vendors based on quality and the needs of the city for this event. The vendor application needs to be mailed, emailed or dropped off by **due date October 2, 2020**. Payment will be due upon approval. Vendors will be selected and notified within 10 days of submittal. \* **Once selected, vendors have 10 days to submit all required permits and licenses or your retail spot will be forfeited.** You must pay for your City Business License first at city hall and then come to Parks and Recreation to pay your vendor fee.
2. All decisions are final and cannot be appealed.
3. Only items which have been approved by the City of Tolleson are allowed at the event. Any items not selected or approved are subject to removal at any time during the event.
4. The City of Tolleson designates all spaces.
5. All setup and equipment is the responsibility of each vendor. **Food trucks must provide their own generators.**
